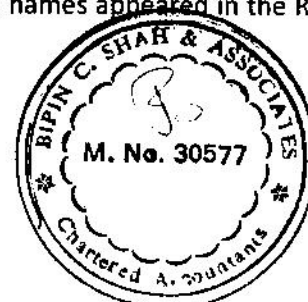

I Bipin Chandulal Shah, Chartered Accountant in practice, have been appointed by the Board of Directors of Kunststoffe Industries Limited as a Scrutinizer for the purpose of

- (i) scrutinizing the e-voting process (Remote E-voting) under the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and
- (ii) Voting through poll under the provisions of Section 109 of the Companies Act, 2013 read with Rule 21 of the Companies (Management and Administration) Rules, 2014 (as amended) on the resolutions contained in the notice to the 29th Annual General Meeting of the Equity Shareholders of Kunststoffe Industries Limited, held on 29th September, 2015 at 128, Kiran Building, Bhaudaji Road, Matunga, Mumbai – 400019.

The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to voting through electronic means (i.e. by remote E-voting and voting by Poll at the AGM) on the resolutions contained in the notice to the 29th Annual General Meeting of the Equity Shareholders of the Company. My responsibility as a scrutinizer for the voting process (i.e. Remote e-voting and voting by Poll at the AGM) is restricted to make a Consolidated Scrutinizer's Report of the Votes cast "in favour" or "against" the resolutions stated above, based on the reports generated from the e-voting platform provided by Central Depository Services (India) Limited (CDSL), the authorized agency to provide e-voting facilities, engaged by the Company and ballot forms or Poll papers provided to the the members attending the meeting, who have not already cast their vote by remote e-voting.

1. The Company engaged the service of Central Depository Services of India Limited (CDSL) (hereinafter referred to as the "Service Provider") to offer the Remote e-voting facility to its shareholders. The Remote e-voting facility was offered and kept open by the Company to its Shareholders for the period commencing on 26th day of September, 2015 (9.00 a.m.) and ending on 28th day of September, 2015 (5.00 p.m.). The shareholders whose names appeared in the Register of



Members / List of Beneficial Owners as on 22nd day of September, 2015 (i.e. cut-off date) were allowed to participate and vote electronically during the aforesaid period of e-voting. On 28th day of September, 2015, the votes cast through e-voting facility were duly unblocked by me in the capacity of the Scrutinizer in the presence of Mr. Prakash Salve and Mr. Vishnu Mirgule who were present as witnesses.

2. At the 29th AGM of the Company held on Tuesday, the 29th day of September, 2015, at 10.00 a.m. at Kiran Bldg., 128, Bhaudaji Road, Matunga, Mumbai – 400 019, a Poll was conducted on all the resolutions to facilitate the members present at the meeting, who did not participate in the e-voting to cast their votes through the poll.
3. Further, 02 (Two) empty ballot (polling) boxes were locked and sealed by me in the presence of the members and the proxies. Subsequent to the completion of polling process, both the ballot (polling) boxes were unlocked by me in the presence of Mr. Prakash Salve and Mr. Vishnu Mirgule and the poll papers were diligently scrutinized by me. The poll papers were reconciled with the records maintained by the Company / Registrar and Transfer Agents of the Company and the authorizations / proxies lodged with the Company,

I have issued separate Scrutinisers Report on the Remote E-voting and on the Poll on the Resolutions contained in the Notice to the AGM. Herewith I am Submitting my Combined Report on E-Voting and Poll.
