Proceedings in brief:

Mrs. Soniya Pravin Sheth, Managing Director of the Company welcomed the shareholders and elected Mr Pravin Sheth to chair the Meeting and address the shareholders.

Majority of the directors of the Company attended the meeting

The Chairperson of all the Committees constituted by the Board, including Chairperson of Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee were present at the Meeting. The Secretarial Auditor was also present at the Meeting. The Chief Financial Officer and the Company Secretary were present throughout the meeting.

The number of shareholders as on record date 18th September, 2023 were 13144.

As per the attendance record 56 Members were present at the Meeting and after ascertaining that the requisite quorum was present, the Chairperson called the Meeting to order.

1. There were no qualifications in the Statutory Auditors' Report on the Financial Statements or the Secretarial Auditors Report and hence, both were taken as read.

The Chairperson informed that, remote e-voting commenced at 9:00 a.m. on Friday, 22nd September, 2023 and concluded at 5:00 p.m. on Sunday, 24th September, 2023.

The following items of business, as per the Notice of AGM dated August 12, 2023, were transacted at the meeting

1. To receive, consider and adopt the Standalone Audited Financial Statements of the Company for the financial year ended 31st March, 2023 together with the reports of the Board of Directors and Statutory Auditor thereon.
2. To reappoint Mrs. Soniya P. Sheth (DIN: 02658794), Managing Director who retires by rotation and being eligible offers herself for re-appointment.
3. To appoint Mr. Pravin Vrajlal Sheth (DIN: 00138797) as a Non-Executive, Non-Independent Director.
4. To appoint Mr. Bhadresh Hasmukhbhai Shah (DIN: 00629457) as a Non-Executive, Independent Director.
